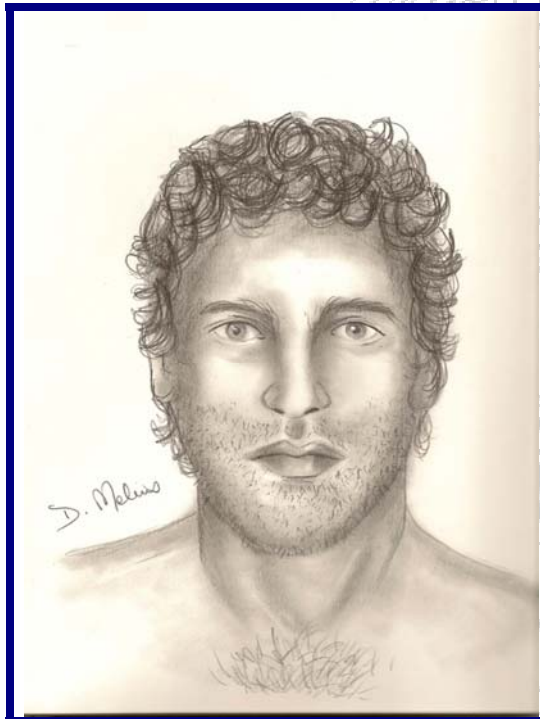

Lakeland Police Seek Public Assistance to Identify Sexual Battery Suspect

The Lakeland Police are seeking the assistance of the public to help identify the suspect of a sexual battery that occurred on Friday, August 15, 2008, in an area southwest of the downtown area of Lakeland. The suspect approached the victim as she was entering her residence, distracted her, then forced her inside where she was raped. The suspect was described by the victim as a white male, 5'08" to 5'9", 35 to 40 years of age. The suspect had light facial hair growth and short brown hair. At the time of the attack, the suspect was wearing a black t-shirt with a white t-shirt underneath, and blue jean shorts.

This incident appears to be a random act.
