Pursuant to the City Code 98-92 approved by Lakeland's City Commission, the owner of a motor vehicle is liable for payment of a minimum civil penalty of \$125.00 for the first and second offense, and \$250 for the third and any subsequent violations within any five (5) year period if the owner's vehicle proceeds into an intersection equipped with a photographic traffic control monitoring system when the traffic control signal for that vehicle's direction of travel is emitting a steady red signal. It has been determined that your vehicle has proceeded into an intersection by entering the crosswalk on the near side of an intersection when the traffic control signal, for the direction in which your vehicle was traveling, was emitting a steady red signal. If you were making a right hand turn, you failed to come to a complete stop at the clearly marked stop line or if none was present, at the point nearest the intersecting roadway where you had a view of approaching traffic on the intersection.

Failure to pay the assessed civil penalty by the Due Date or failure to appear at a scheduled hearing to contest the notice will be considered an admission of liability and an order may be entered against you for an amount up to the maximum civil penalty, plus any administrative costs.

No points will be assessed against you for the civil penalty. Your failure to respond may result in an order constituting a lien to be filed against real and personal property and/or the denial of the right to obtain and maintain any City permits or licenses.

THERE ARE TWO WAYS TO CONTEST THIS VIOLATION:

(1) You may contest the imposition of this civil penalty by signing and mailing the coupon below to request an appearance before a Hearing Officer. You may also take the signed coupon below to the Lakeland City Clerk, 228 S. Massachusetts Avenue, 3rd Floor, Lakeland, FL 33801 between the hours of 8:00 AM and 5:00 PM Monday through Friday. Your request must be received by the Due Date stated on the front of this Notice. Upon receipt, you will be notified of the date, time and location of your Hearing.

(2) If the basis of your contest is one of the affirmative defenses outlined in Chapter 98 of the City of Lakeland Code, you may complete an Affidavit of Non-Responsibility and attach supporting documentation. Your affidavit and supporting documentation will be reviewed and will result in either dismissal of this violation or scheduling of an administrative hearing. You will be notified in writing of any action taken.

You may download an Affidavit of Non-Responsibility at www.ViolationInfo.com. You will need your Notice # and Pin# printed on the front of this notice to download the affidavit. The Affidavit must be completed, signed, notarized, and mailed, with all supporting documentation, to the City of Lakeland, Violation Processing Center, P.O. Box 59995, Phoenix, AZ 85076-9995 and it must be received by the due date stated on the front of this Notice.
