- I SHALL NOT USE OR PERMIT any dishonest or unethical practice that tends to corrupt or undermine our system of free elections, or that hampers or prevents the full and free expression of the will of the voters, including acts intended to hinder or prevent any eligible person from registering to vote, enrolling to vote, or voting.
- I SHALL NOT unreasonably pressure or intimidate volunteers for election help or campaign contributions for myself or for any other candidate or from my employees.
- I SHALL accept responsibility to take firm action against any subordinate who violates any provision of this code or the laws governing elections.
- I SHALL DEFEND AND UPHOLD the right of every qualified American voter to full and equal participation in the electoral process.
