Business Tax Receipt Requirements

A Business Tax Receipt (Formerly an Occupational License) is a requirement by the city for all businesses operating within city limits, and must paid yearly. A receipt for payment of the Business Tax is commonly known as Business Tax "Receipt" (BTR). An individual or business that pays the Business Tax is only granted the privilege of doing business within city limits. Payment of such does not constitute the approval of any governing authority responsible for overseeing and/or regulating a trade, practice, activity or service, etc. Most Business Tax fees are based on square footage, number of employees and/or category of profession. Actual Business Tax fees are determined after contacting the Business Tax Office -863-834-6025. In addition, a Polk County Business Tax receipt is required as well.

Reminder- The appropriate Zoning designation is necessary for ALL businesses, including home based businesses

Requirements:

- 1. **Fictitious Name Registration** if you do not use your full name (First & Last) in your business name, the State of Florida requires you to register. To register contact the Department of State Division of Corporations (850)245-6058 *or* register on-line https://dos.fl.gov/sunbiz/
