

RESOLUTION NO. 5137

PROPOSED RESOLUTION NO. 14-036

**A RESOLUTION RELATING TO THE ELECTRIC UTILITY;
ESTABLISHING THE FUEL CHARGE FOR ALL
CUSTOMER CLASSES FOR METERS READ ON OR
AFTER AUGUST 1, 2014; MAKING FINDINGS;
REPEALING RESOLUTIONS 5105 AND 5124;
PROVIDING AN EFFECTIVE DATE.**

WHEREAS, Ordinance 5187, as amended, created the authority for establishing a fuel charge for each quarter; and

WHEREAS, the City Commission of the City of Lakeland, Florida must determine the projected system average fuel costs, projected power purchases, and projected energy generated in order to establish the fuel charge; and

WHEREAS, Ordinance 5187, as amended, requires the Lakeland Electric Staff to periodically review the information and projections upon which the fuel charge is based and, if necessary, amend the fuel charge to be consistent with more current information, and

WHEREAS, the City Commission of City of Lakeland has considered all information necessary for the determination of the fuel charge and recognizes the necessity to establish an amended fuel charge by increasing the fuel charge established by Resolution 5124 of the City Commission of the City of Lakeland by 2.50 mill(s).

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION
OF THE CITY OF LAKELAND, FLORIDA:**

SECTION 1. The foregoing findings are incorporated herein by reference and made a part hereof.

SECTION 2. The fuel charge for all rate classes in existence on the effective date, or rate classes which may be created in the future, for the period commencing August 1, 2014, and thereafter is hereby increased from 43.35 mill(s) by 2.50 mill(s) to 45.85 mill(s).

SECTION 3. The time-of-day fuel charge for applicable rate classes in existence on the effective date, or rate classes which may be created in the future for the period commencing August 1, 2014, and thereafter, is hereby set as a percentage of the fuel charge:

	On-Peak	Mid-Peak	Off-Peak
Two Period	113.2%	- - -	93.3%
Three Period	114.4%	99.1%	96.2%
PEV	106.1%	- - -	81.7%

SECTION 4. Resolutions 5105 and 5124 of the City of Lakeland, Florida are hereby repealed. All other resolutions or parts of resolutions in conflict herewith are hereby repealed.

SECTION 5. The charge established herein shall be applied to bills rendered for all meters read on or after August 1, 2014.
